The ground layer of the atmosphere represents the largest source of ambient light and appears to be a significant factor in the formation of the first light images from space. Observations of the scintillation of the earth's atmosphere indicate that the atmosphere acts to increase the coherence of the initial laser beam. Anisotropic characteristics of scintillation have also been observed. Results from experiments on laser scattering in the atmosphere are reported here in which a laser beam is passed into a chamber that contains a scattering medium. The beam profile is first measured and then the anisotropy parameter alpha from the measurements of the beam is derived. The atmospheric signal levels are confirmed as proportional to the number of particles within a scattering volume. Experimental results show that the larger the number of particles within the scattering volume, the lower the turbulence level. The directional scattering coefficients of water vapor and air have also been calculated and shown to be anisotropic. The label 'colic' brings with it connotations of distress and affects the parents and the child's carer more than it does the clinician. It is generally assumed that if a patient presents in what they believe is a time of pain the diagnosis should be 'colic' not 'colicky'. However, colonic pain is present in up to 20% of infants, and a significant proportion of that pain is not colicky.
